In consideration of allowing the Participant to compete in the Event(s), the Parent/Legal Guardian named above hereby releases 7666705 Canada Inc. - This Competition is being administered by CHEER EVOLUTION. The judges will make all final decisions on the placing of each team (this includes deduction and disqualification penalties). The decision of the judges is FINAL and is not open to discussion.
- The COACH is responsible for adherence to all rules listed in the General Guidelines and Policies and Registrations. The guidelines are set forth on the CHEER EVOLUTION Website, **www.canadiancheer.com**
- I further acknowledge that CHEER EVOLUTION uses a leveling system for their competition divisions. I am aware of the rules pertaining to each division, and agree to abide by them. I take full responsibility for knowing the rules and limitations for each division.
- The COACH, team, and fans of the team (i.e. Parents/Spectators) will demonstrate appropriate sportsmanship before, during, and after the competition.
